CONTINUING PROFESSIONAL DEVELOPMENT:

Social Workers: Since 1 April 2005 all qualified social workers within the UK must be registered with the General Social Care Council (GSCC). Annual re-registration is necessary and for the year commencing 1 April 2008 evidence will have to be provided of 15 days (90 hours) CPD (continuing professional development) undertaken over the preceding three years. This course would contribute to social work CPD hours.
